**Sub:- Issuance of NOC for affiliation with CBSE, New Delhi to STS World School.**

Sir/Madam,

Concerning the above mentioned subject-this is to inform the school management that a No Objection Certificate (NOC) has been issued to the school for the affiliation with CBSE, New Delhi, after the careful observation of the certificates, documents and affidavits produced by the school management to the District Education Officer (SE), Jalandhar and Director of Education Department (SE) Punjab, Chandigarh on the following conditions.

1. If it will found in future the Documents, Certificates or Affidavits produced at the time of NOC proves to be false or based on wrong fact during the inspection at any time in the school, or the school is not following the rules and regulations prescribed by the Punjab Government or the school is not following the conditions mentioned in the affidavits, then the board may any time cancel the NOC.
2. Punjabi is taught in your school as a compulsory subject upto 10<sup>th</sup> class and CBSE, New Delhi takes necessary steps to conduct the examination of Punjabi subject. Failure to do so, the Punjab Government may cancel the NOC.
3. The school management follows the notifications and rules mentioned in the RTE act, 2009 by Punjab School Education Board.
4. After getting the affiliation from CBSE, New Delhi the school management will pay the salary and other allowanc to the Employees through account payee cheque only according to the norms of Government Employee.
5. You and your school management are to make sure to produce any type of document as and when required by the DEO or any other senior officer from Education Board. Failure to do so will result in cancellation of NOC.
